1. I do hereby acknowledge and agree that the AquaDoula Spa identified in this Rental Contract will be leased to me, the Lessee, by said Lessor.
2. Lessee understands that the lessor recommends that all births be attended by experienced birth professionals.
3. Less understands the above stated rental price is founded on a per birth basis for a period of three (3) weeks.
4. Lessee agrees to pay lessor for any applicable shipping, handling or delivery charges.
5. Lessee agrees that this agreement is non-transferable.
6. Lessee acknowledges that the rental spa is specifically limited to indoor use.
7. Lessee agrees to take full responsibility for the manner in and purpose for which said AquaDoula spa is used.
8. Lessee agrees to empty AquaDoula of water and remove disposable liner and dry all water before pick-up and disassembly of spa.
9. Lessee agrees to pay for the replacement or repair of said AquaDoula Spa (and accompanying components) in the event of damage or non-return.
10. Lessee understands that there will be no reduction in the rental fees if the AquaDoula Spa is unused during the rental period or if the AquaDoula Spa is returned before the birth. Lessee understands that the rental fee is nonrefundable, and that no portion of the rental fee will be refunded with the exclusive exception that the baby is born before delivery of the AquaDoula Spa. The Lessee will be refunded their rental fee less a \$75 non-refundable portion.
11. Lessee agrees to release and hold harmless Lessor and/or any agent thereof, its members, employees, associates, and affiliated manufacturers from any and all responsibility of liability for maternal complications, infant mortality or morbidity, or injury to any or all persons in connection with use of said AquaDoula Spa that may occur before, during and/or after labour and/or birth in the AquaDoula Spa provided by Lessor.
12. Lessee specifically holds Lessor harmless from any claims made by third parties, as well as any damage or injury to property occasioned by the use of the AquaDoula Spa during the rental period or while the AquaDoula Spa is otherwise in possession of the Lessee, and furthermore agrees to indemnify Lessor for any and all liability or expenses, including attorney's fees, incurred by Lessor occasioned by the use of the AquaDoula Spa during the rental period or while the AquaDoula Spa is otherwise in possession of the Lessee.
